



LOCATION

Arundel is located 10 miles (16 km) east of Chichester, 20 miles (32 km) west of Brighton and 9 miles (14.5 km) north of Worthing. The town has a resident population of 3,496 (2021 Census).

This historic town has over 1000 years of history and attracts tourists to Arundel Castle and Arundel Cathedral. There is a vibrant mix of independent shops, art galleries, restaurants and cafes.

Arundel station is 13 mins (0.6 miles) with regular services to London Victoria. Public car parks in River Road (64 spaces) and Queen Street (151 spaces).

DESCRIPTION

The Old Print Works is located in Tarrant Street close to the junction with the main High Street.

The Old Print Works comprises sixteen small retail units incorporating eleven occupiers arranged over ground and first floors in an attractive arcade. The upper parts comprising the Penthouse, Flats 2 and 3 Old Printing House Square were sold off on long subleases of 215 years from 24th June 1982.


